FY18 Service Summary Legal Department

Mission:

Prosecute misdemeanor and infraction citations; represent the City in legal proceedings, negotiations and other matters; provide legal services to numerous City boards and commissions, while also providing constant availability to Department Heads/Staff and Council Members.

Outcome Summary:

- PROSECUTION RELATED (2 Prosecutors, 2 Staff)
- Staff take approximately 500 phone calls/in-person visits per month
- Prosecutors and staff receive approximately 10 emails per month requesting things such incident reviews and citation amendments
- Prosecutors additionally take approximately 20 unscheduled monthly walk-in meetings with various law enforcement officers, defendants, victims, other attorneys, etc.
- 4,441 Hearings/Court Appearances
 - 499 Infraction Pre-Trials, 49 Court Trials
 - 2,080 Misdemeanor Pre-Trials, 688 Misdemeanor Jury Pre-Trials
 - 171 Domestic Battery Hearings, 315 Domestic Review Hearings
 - 636 Evidentiary and Other Miscellaneous Hearings (suppression, limine, etc.)
 - 3 Jury Trials Held

Outcome Summary:

- CIVIL RELATED (2 attorneys and 1 staff)
- 313 contracts, agreements and other miscellaneous documents reviewed; 88 for Council consideration
- Preparation of 47 Council Decisions, 2 resolutions, 24 Ordinances including those amending/enacting City Code
- Staff take approximately 400 civil related phone calls/visits per month
- On average 4-5 meetings per day with City Department Heads/staff and/or Council Members
- Numerous water rights and other litigation related meetings, negotiations & court hearings
- Preparation/review of numerous plats, deeds, development/infrastructure agreements, letters, opinions and process development memorandums prepared each month

Service Measures of Effectiveness:

- Legal advice difficult to quantify but:
 - Coordination between Legal and Police Departments results in successful prosecutions and victim assistance, including restitution.
 - Legal review and advice reduces potential for litigation or establishes better grounds to be successful in litigation.
 - Environmental and water law issues safeguard community future and quality of life.
 - Economic development, coordinated with Legal Department, results in more efficient growth.
 - Needed changes to and compliance with correct processes are key to reducing liability.

Service Issues and Concerns:

- City growth will require additional legal services or delay service
- Ongoing litigation involving the City of Pocatello requires significant oversight and input from the Legal Department as well as other departments
- Not seeking additional personnel at this point, but seems likely in the next fiscal year
